Peck Criminal Timeline

1993

- **Aug. 3:** Peck is convicted of lewd conduct in public, battery, petty theft, and being a minor in possession of alcohol in Crescent City.
- Aug. 5: Peck is convicted of disturbing the peace and vandalism in Crescent City.
- **Nov. 2:** Peck is convicted of contributing to the delinquency of a minor and trespassing in Crescent City.

1994

- June 13: Peck is convicted of petty theft with a prior in Crescent City.
- **Aug. 25:** Peck is convicted of joyriding, aiding and abetting, and battery on a peace officer in Del Norte County. He is sentenced to three years supervised probation.

1995

Feb. 9: Peck is convicted of vehicle theft in Del Norte County and sentenced to three years supervised probation.

1999

June 14: Peck is convicted of check fraud in Crescent City.

2003

- **Feb. 5:** Peck is convicted of resisting or obstructing a peace officer and violating a court protective order in Sacramento.
- **Nov. 3:** Peck is convicted of petty theft with a prior in Humboldt County.

2005

Feb. 9: Peck is convicted of two counts of using a minor to transport or sell marijuana in Humboldt County.

2009

April 24: Peck is convicted of providing false ID to a peace officer and possession of a hypodermic needle without a prescription in Humboldt County.

2014

- Feb. 14: Peck allegedly steals merchandise from Macy's.
- **Feb. 24:** Peck fails to appear for arraignment over allegations of petty theft from Macy's with priors. A bench warrant is issued.
- March 21: Peck is arrested and booked into jail.
- **April 24:** Peck fails to appear in court; a bench warrant issued.
- **May 1:** Peck is convicted of second-degree burglary, reduced to a misdemeanor, in San Mateo County.

2015

- **Sept. 15:** Peck allegedly steals more than \$950 in merchandise from CVS.
- **Sept. 19:** Peck allegedly steals more than \$950 in merchandise from CVS.
- **Dec. 6:** Peck allegedly steals more than \$950 in merchandise from CVS.
- **Dec. 29:** Peck allegedly steals more than \$950 in merchandise from CVS.
- **Dec. 30:** Peck allegedly steals more than \$950 in merchandise from CVS.

2016

- **Jan. 4:** Peck is charged with two counts each of second-degree burglary and grand theft from CVS. He pleads not guilty to all four counts; stay-away orders are issued, and bail is set at \$50,000.
- **Jan. 7:** Peck pleads not guilty to petty theft charges in Macy's case. He is charged with three additional counts of grand theft from CVS and pleads not guilty.
- **Jan. 11:** Peck is released on his own recognizance in all cases and ordered to report to the Community Justice Center for evaluation.
- **Jan. 26:** Peck fails to appear in court. Bench warrants are issued, and his recognizance status is revoked.

2017

March 22: Peck allegedly steals Claritin from the Target location in the Metreon. He is arrested and booked on a warrant for failing to appear in the Macy's case.

- **March 23:** Peck is charged with petty theft for the alleged March 22 theft. The court orders a medical examination.
- **March 27:** Peck pleads guilty to one count of second-degree burglary in the 2015 CVS theft case; the three other counts in that case are dismissed as part of a plea deal. He is released on his own recognizance.
- **March 28:** Peck fails to appear for court dates in theft cases. Bench warrants are issued.
- March 30: Peck is arrested and booked into jail.
- **April 3:** Peck is released on his own recognizance and ordered to report to the Community Justice Center mental health program for evaluation.
- **April 13:** Peck fails to appear for multiple court dates and a CJC progress report hearing; bench warrants are issued.
- **Sept. 12:** Peck is arrested and booked on bench warrants.
- Sept. 18: Peck is released on his own recognizance in all cases.
- **Sept. 25:** Peck fails to appear in court; bench warrants are issued.
- Oct. 4: Bench warrants are recalled; Peck is released on his own recognizance.
- Nov. 29: Peck fails to appear in court; bench warrants are issued.

2018

- **Jan. 23:** Peck is arrested and booked on bench warrants in multiple cases.
- **Feb. 1:** Peck is convicted of second-degree burglary in San Francisco. Four other cases were dismissed as part of a plea agreement. He is sentenced to three years felony probation.
- **Aug. 15:** Peck fails to appear in court. The district attorney's motion to revoke probation is approved, and a bench warrant is issued.

2019

- May 1: Peck is booked into jail after failing to appear in court.
- **May 21:** Probation is reinstated under previous terms after the court reviews a supplemental report. Probation is extended to Nov. 7, 2021. As part of probation, Peck is ordered to serve 42 days in county jail but receives 21 days credit for time already served during trial. He must participate in the Community Assessment and Services Center behavioral health case management program upon release. It's unclear from court records if he reported to behavioral

health services upon his June 4 release from jail.

- **Oct. 21:** Peck is arrested for allegedly stealing more than \$950 in drugs from Walgreens at 1899 Fillmore St.
- **Oct. 24:** Peck is charged with grand theft, second-degree burglary, and possession of burglary tools
- Oct. 28: Peck fails to appear in court; probation is revoked. He is remanded into custody.
- **Oct. 31:** Peck pleads not guilty to all three counts in the Walgreens case. He is held in custody and ordered to stay away from Walgreens upon his release.
- **Nov. 12:** Peck is released to pretrial diversion with ankle monitoring. The court orders him to report to residential treatment with the Salvation Army. He must not consume alcohol, marijuana, or controlled substances without a prescription.
- **Nov. 13:** Peck leaves the Salvation Army intake in violation of the court's conditions. He tells his case manager he doesn't want to participate and plans to cut off his ankle monitor.
- **Nov. 14:** The public defender files a motion to suppress evidence, claiming it was obtained unconstitutionally.
- **Nov. 16:** Peck is booked into jail.
- **Dec. 5:** Peck pleads guilty to grand theft from a Walgreens at 1899 Fillmore St.; other counts are dismissed. He is released on his own recognizance with a six-month condition for failure to appear.

2020

Feb. 11: Peck fails to appear for sentencing and hearing; a bench warrant is issued and probation revoked.

2022

- **July 7:** Peck fails to appear in court. Bench warrants are issued for two pending theft cases: one involving alleged thefts from two CVS stores in 2015, and another involving alleged theft from a Walgreens in 2019. Probation is revoked.
- **Aug. 19:** Peck is convicted of grand theft, sentenced to two years probation, and ordered to pay restitution and stay away from Walgreens. The previous probation case is terminated and deemed successful.
- **Aug. 29:** Peck fails to appear to a court hearing on probation progress; the bench warrant is stayed.

Oct. 11: Peck fails to appear in court, and his probation is revoked.

2024

- **March 11:** Peck is arrested on a bench warrant for not appearing for a probation hearing and booked into jail.
- **April 19:** Peck appears in court after an appearance is rescheduled multiple times. Probation is reinstated until Aug. 19.
- **June 13:** Peck is charged with loitering to commit drug offenses and possession of drug paraphernalia.
- **June 18:** Peck pleads not guilty and is ordered to pretrial diversion for two months and released on his own recognizance. He is ordered to attend five Narcotics Anonymous classes and obey all laws.
- **Oct. 3:** Peck fails to appear for a pretrial diversion progress report; a bench warrant is stayed until Nov. 19.
- **Oct. 7:** Peck allegedly steals \$306.86 in over-the-counter medication from Target at the Metreon.
- Nov. 19: Peck fails to appear; a bench warrant is issued.

2025

- **Feb. 22 to May 23:** Peck allegedly steals \$7,541.94 in over-the-counter medication, toothpaste, hair appliances, razors, gum, and clothing across 16 alleged thefts from Target at the Metreon. Peck is arrested on May 23 for an outstanding bench warrant issued due to his failure to appear for a pretrial diversion progress report in a different pending case.
- **May 26:** Peck is denied release; bail is set at \$25,000.
- **May 29:** Peck is charged with second-degree commercial burglary and attempted grand theft for a May 23 theft from the Metreon Target. He refuses to appear and is held without bail. The district attorney says Peck was charged with 14 counts of shoplifting with priors, one count of second-degree commercial burglary, one count of grand theft and one count of commercial shoplifting.
- June 3: Peck refuses to appear and remains held without bail.
- **June 4:** Peck pleads not guilty and denies allegations; he is deferred to Jail Behavioral Health Services and pretrial diversion.
- June 5: The district attorney files a motion to consolidate Peck's cases, arguing that the

charges are "of the same class and are connected in their commission."

June 17: Peck changes his plea to no contest and is released with ankle monitoring.

June 30: The San Francisco sheriff seeks an arrest warrant for Peck for alleged violations of release conditions.

July 31: Peck is arrested and booked on a bench warrant.

Aug. 6: Peck refuses to be transported to court for a hearing on custody status and change of plea. The hearing is postponed to Aug. 12.
