



Are you starting on 1/18?

The woman I reversed came up to me at the end and thanked me for saving her and asked if she could hug me. I said off course, and we had a beautiful hug with her head on my heart.
























I know- I was teasing. I am very conscious of how much emotional and spiritual energy it takes to do this work, and it's critical that we take care for ourselves as well




